Dragon Mountain Gold Limited (“DMG” or “the Company”) is pleased to provide this Quarterly Activity Report for the quarter ending 30 June 2016.

During the quarter, the Board conducted due diligence on the gold rights for the Cawse and Avalon project in Western Australia. On 11 July 2016, the Company announced that it had signed a Heads of Agreement for the gold and other mineral rights, excluding nickel and cobalt, with Wingstar Investments Pty Ltd, a Company associated with Company chairman, Robert Gardner.

The Company had \$3.527 million in cash reserves at the end of the quarter.
